International Seminar on Indonesia Arbitration Law Nr. 30 of 1999 concerning Arbitration and ADR

BACKGROUND

Sixteen years ago, on 12 August 1999, the government of Indonesia enacted and promulgated Law Nr. 30 of 1999 on Arbitration and Alternative Dispute Resolution (Arbitration Law), as the first national arbitration law in Indonesia. In drafting the law, Indonesia departed from its South East Asian neighbors, which chose to adopt UNCITRAL Model Law on International Commercial Arbitration.

On its face, the Law Nr. 30 of 1999 has offered predictability and harmonization with global standards, which have helped drawn domestic and foreign investments. Under the reciprocity reservation, foreign arbitral awards can only be enforced in Indonesia if the country deciding on the award is also a contracting state to the New York Convention.

Although the law is also applicable for international arbitration, many viewed that current law has been oriented for resolving domestic disputes. Given such perspective, the following seminar is designed to review the various issues in the implementing arbitration law both for domestic and international arbitration with the objective to identify parameters that are pertinent in the arbitration process including the enforcement. The information gathered in the seminar will be presented to the law maker, for the use in preparing the new arbitration law.
