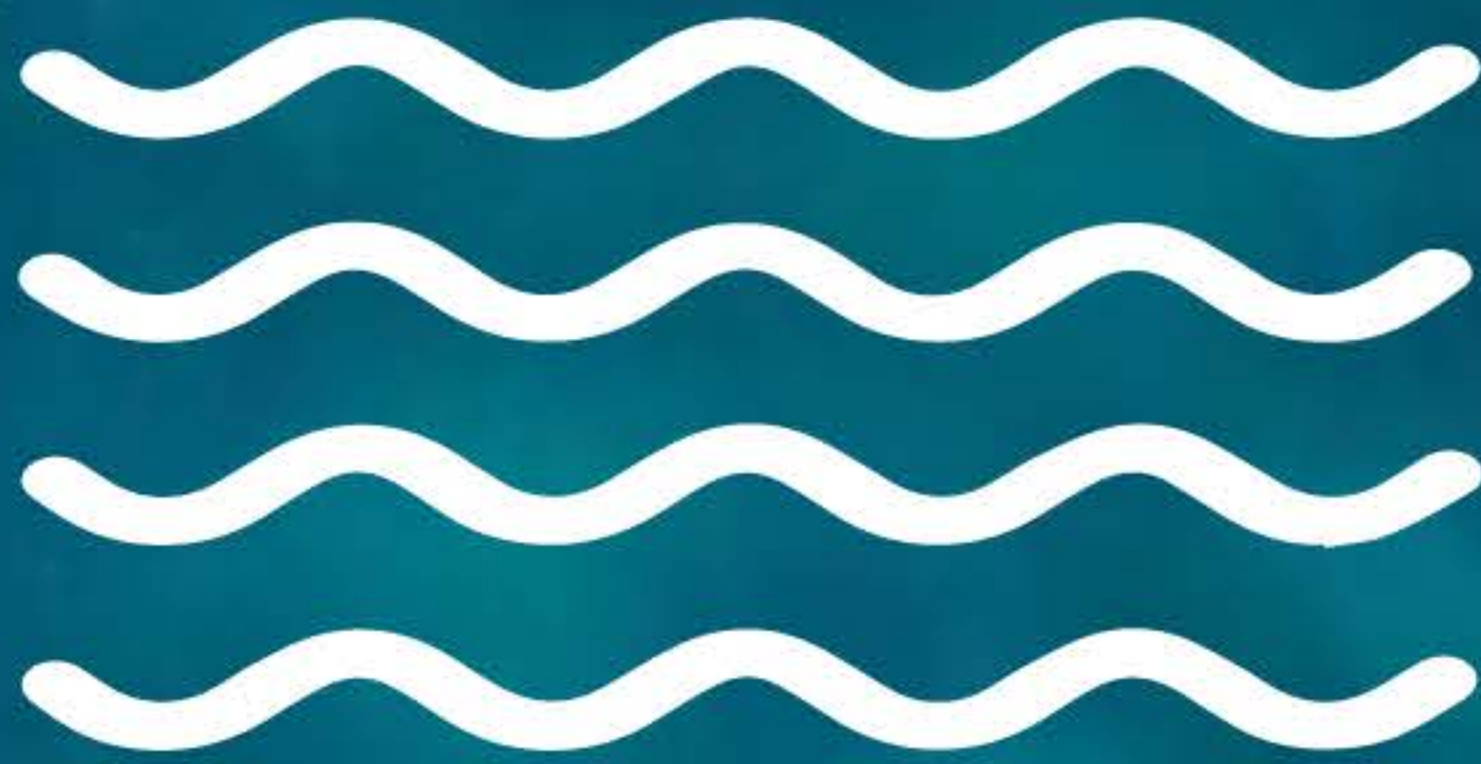

2024: Strengthening SCMA's Global Reach and Thought Leadership

As we reflect on 2024, the maritime and trade industries continue to face profound transformation shaped by technological advances, evolving regulatory landscapes, and the increasing need for a greener maritime future. At the Singapore Chamber of Maritime Arbitration (SCMA), our mission remains steadfast: to provide adaptive, efficient, and fair dispute resolution mechanisms that empower the maritime and international trade communities to meet these challenges head-on.



Key Milestones and Initiatives

In January, we marked the inauguration of the SCMA-SIMC Maritime Mediator Panel, a pioneering joint initiative taken with the Singapore International Mediation Centre (SIMC).

This platform offers parties an additional pathway to resolve disputes efficiently and amicably, reflecting our commitment to diversifying dispute resolution mechanisms.

Our Perspective Seminar Series with esteemed chambers—Essex Court Chambers, 7 King's Bench Walk and Quadrant Chambers — continued to provide a platform for robust discussions on contemporary legal challenges. These seminars reaffirmed SCMA's role in shaping the discourse around maritime law and arbitration.

The launch of new global collaborations was another highlight. In July, SCMA formalised Memoranda of Understanding (MOUs) with the Shanghai Maritime University (SMU) and the Shanghai International Arbitration Center (SHIAC), strengthening academic and institutional ties.

Expanding Our Global Footprint

This year also saw a concerted effort to extend SCMA's reach across key maritime hubs. Marketing trips were made and seminars held in Mumbai, Bangkok, Jakarta, Qingdao, Ningbo, Seoul, London, and Hai Phong showcasing SCMA's dispute resolution offerings and engaging stakeholders in vibrant maritime communities.



Our Distinguished Speaker Series held during Singapore Maritime Week (17 April) highlighted critical industry issues, including decarbonisation and the challenges of geopolitical uncertainties. Similarly, our Marine Fuels Forum (15 May) and Clyde & Co Seminar (19 September) provided valuable insights into emerging fuel regulations and trade dynamics.

Thought Leadership and Industry Collaboration



2024 marked the successful completion of the 4th Maritime Arbitrators' Accreditation Programme (MAAP), conducted by leading arbitrators. This programme drew participants from over 10 countries and reinforced SCMA's reputation as a centre for excellence in maritime arbitration training.

We also sponsored and took on the main secretariat role for the International Maritime Law Arbitration Moot (IMLAM) 2024. By investing in the next generation of legal professionals, SCMA continues to play a pivotal role in nurturing the future leaders of maritime law and arbitration.

Engaging the Maritime Ecosystem



SCMA remains committed to building bridges within the maritime industry. This year, we hosted inaugural events such as the In-House Lawyers' Group Meeting (1 August), fostering dialogue among legal professionals.

Our annual Great Debate (29 August) sparked lively discussions on the future of arbitration, while the Arbitrators' Formal Dinner (5 November) celebrated the achievements of SCMA arbitrators.

As part of our educational efforts, SCMA continued its support for the International Maritime Law Arbitration Moot (IMLAM), hosting a successful event on 12 July.

Looking Ahead



As we move into 2025, SCMA remains steadfast in its vision to be a "by members, for members" institution. Initiatives such as the formation of the Arbitrators' Representative Council (ARC), the Members' Consultative Council (MCC), and the In-House Legal Counsel Group (ILG) will empower our members to actively shape SCMA's future.

We also successfully concluded our flagship SCMA Conference in March 2025, and are preparing for the XXIII International Congress of Maritime Arbitrators (ICMA) in March 2026, a prestigious event that will showcase Singapore's leadership in maritime arbitration on the global stage.

Last year's achievements would not have been possible without the unwavering support of our stakeholders, partners, and members. I extend my deepest gratitude to all who have contributed to our success in 2024. Together, we will continue to position Singapore as a global hub for maritime and trade dispute resolution.

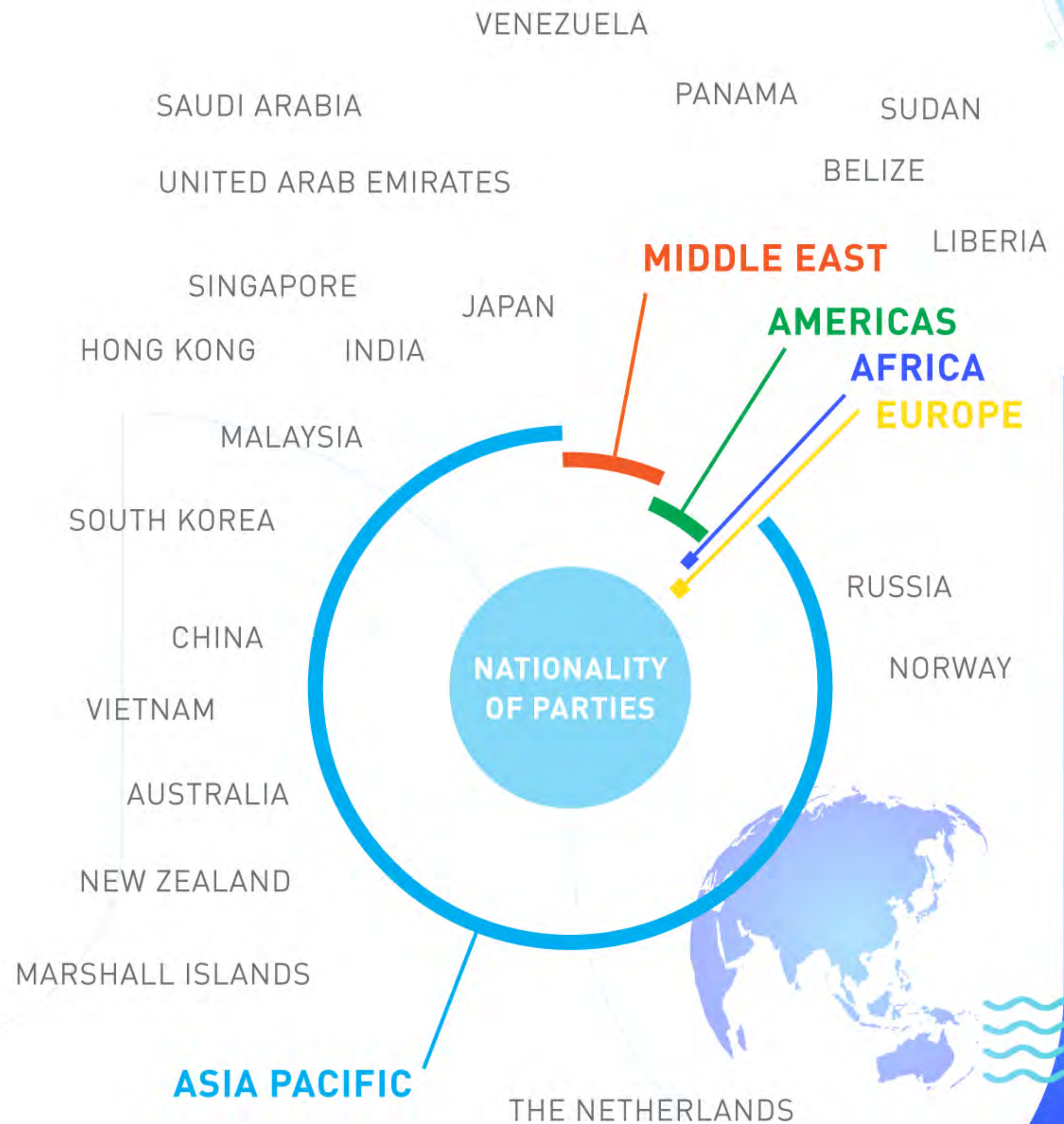

INAUGURATION OF SCMA-SIMC MARITIME MEDIATOR PANEL

12 JUL 2024

The inaugural batch of the Singapore Chamber of Maritime Arbitration (SCMA) - Singapore International Mediation Centre (SIMC) (SCMA-SIMC) Maritime Mediators Panel was launched at the Singapore Maritime Foundation (SMF)'s New Year Conversations 2024, which was also in celebration of its 20th anniversary.

The SCMA-SIMC Maritime Mediators Panel aims to facilitate the appointments of qualified mediators for resolving maritime and shipping disputes, while also promoting the wider adoption of mediation in suitable cases within the maritime industry.

Mediation has emerged as a compelling alternative dispute resolution mechanism, offering parties an interest-based, cost-effective, and confidential method of resolving disputes amicably within the maritime industry. The collaboration between SCMA and SIMC will further strengthen Singapore's position as a leading dispute-resolution hub for the maritime and international trade industries.

Through the SCMA – SIMC Maritime Mediators Panel, both institutions will be able to nominate qualified mediators to facilitate the resolution of their maritime or shipping disputes. The institutions will develop criteria and guidelines for the admission of suitable mediators, ensuring the highest standards of professionalism and expertise in mediating maritime and trade disputes.

The first SCMA Perspectives Seminar **"THE FUTURE OF ARBITRATION: REFORM IN ENGLAND, AND A COMPARISON WITH SINGAPORE'S APPROACH"** was held on 10 January 2024, run jointly with Essex Court Chambers and Allen & Gledhill LLP.

In this seminar, the speakers, Chris Smith KC and Wei Jian Chan of Essex Court Chambers discussed their insights regarding the publication of the long-awaited final report by the Law Commission of its review of the UK Arbitration Act 1996 and a draft bill setting out the recommended amendments to the Act.

Daniel Liang of Allen & Gledhill LLP moderated the seminar and provided his views on the relevance of these recommendations in the context of Singapore law.

"ALLEGING CONSPIRACY TO USE UNLAWFUL MEANS" was held jointly on 25 January 2024 with 7 King's Bench Walk (7KWB).



During the Seminar, Mr Stephen Kenny KC of 7KWB presented on the emergence of the tort of conspiracy along with its division into conspiracy to use unlawful means and conspiracy to injure without using unlawful means.

He also touched on the development of the tort of conspiracy, what it is to be a conspirator and the probable advantages in developing a claim in terms of conspiracy to do harm by unlawful means.

Ms Gemma Morgan, Barrister at Quadrant Chambers presented the **LATEST KEY JUDGMENTS AFFECTING THE SHIPPING SECTOR FROM THE ENGLISH COURT OF APPEAL & SUPREME COURT**: Herculito Maritime Ltd v. Gunvor International BV ("The Polar"), FIMBank p.l.c. v KCH Shipping Co. Ltd ("The Giant Ace") and Unicredit v Euronav ("The Sienna").

Ms Xeauwei Tan, a Partner specialising in dispute resolution at Allen & Gledhill LLP, moderated the seminar and discussed the perspective of the banks, in view of these judgments.

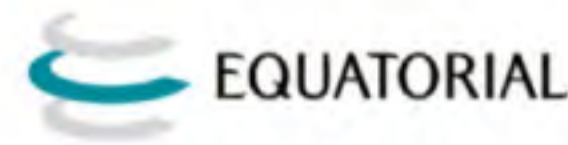

The Singapore Chamber of Maritime Arbitration (SCMA) was pleased to return to India on 1 February 2024 with our SCMA Maritime Law and Arbitration seminar in Mumbai, which was graced by Mr Cheong Ming Foong, the Consul-General of Singapore's Consulate-General in Mumbai.

Together with the Maritime and Port Authority of Singapore (MPA) and along with supporting organisations including the Indian Nation Shipowner's Association (INSA), the ICS Mumbai branch (Institute of Chartered Shipbrokers) and the ICS Madras Branch (Institute of Chartered Shipbrokers) as well as our SCMA member law firms, Norton Rose Fulbright Singapore, Oon & Bazul LLP and Rajah & Tann Asia, SCMA organised a half-day seminar that covered topics relating to legal and arbitration in the context of maritime and international trade sectors.

The seminar ended with closing remarks from Capt John Prasad Menezes, the Chairman of the ICS East India branch, one of the supporting organisations for the SCMA seminar, followed by a networking reception.

The Singapore Chamber of Maritime Arbitration (SCMA)'s recent trip to Qingdao saw successful collaborations with our Chinese partners. The first was with the China Maritime Arbitration Commission (CMAC), Qingdao Branch, where we jointly hosted over 120 participants from the Qingdao maritime sector, including local maritime port authorities, state-owned maritime enterprises, shipowners, and legal professionals, at a joint SCMA- CMAC networking reception held at the CMAC Qingdao Centre. The SCMA was honoured that the reception was also graced by Mr. Lihu Deputy Chairman of CMAC.

Prior to networking over drinks and food, SCMA and CMAC Qingdao Branch were joined by our colleagues from the Maritime and Port Authority of Singapore (MPA). Ms Woei Tyng Tan, Senior Director (International Maritime Centre Division) of MPA made a presentation on how Singapore continued to build maritime capabilities whilst highlighting some of MPA's key initiatives in decarbonisation, digitalisation, and cybersecurity. Kevin Yong SCMA's Deputy Executive Director, introduced the Chambers and explained how the SCMA arbitration rules might benefit the dispute resolution needs of Chinese players in the maritime and international trading sectors.

The second collaboration was that with the Shandong Maritime Safety Administration (MSA) and the Shandong Pilot Free Trade Zone Qingdao (SDP-FTZ Qingdao), both of whom were introduced to SCMA by Singapore's MPA. SCMA gave a presentation to an audience of more than 120 participants on our arbitration rules, such as the Main Rules and the Expedited Procedure, at the seminar jointly hosted by Singapore MPA, Shandong MSA, and the SDPFTZ Qingdao. The joint seminar covered a spectrum of topics such as port security management, the development of Qingdao Free Trade Zone, Singapore's Flag State Control inspections, green fuel bunkering, and various maritime safety regulations.

During our trip to Qingdao, SCMA also took the opportunity to visit several shipping companies and associations to promote awareness and heighten the understanding of the use of SCMA arbitration rules for resolving their disputes. SCMA was thankful to have the chance to conduct meaningful discussions with these companies to explore potential future collaborations with them.

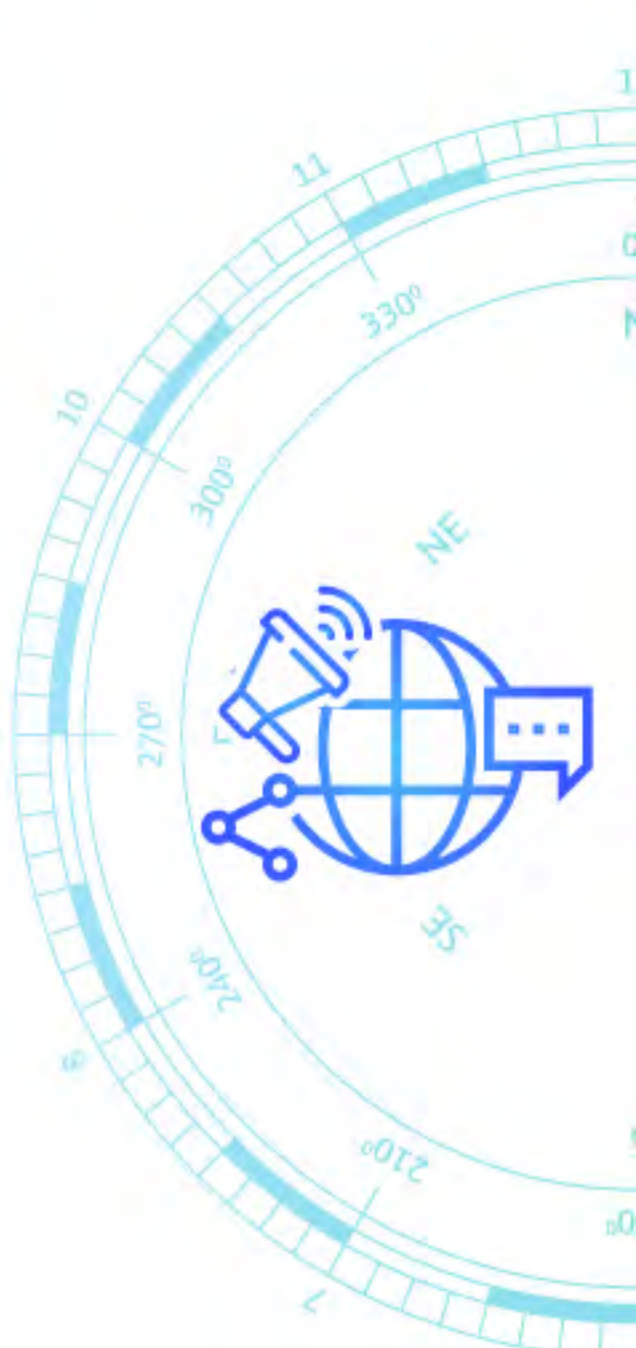
SCMA participated in the Dalian Arbitration Week, organised by Dalian International Arbitration Court, for the first time.

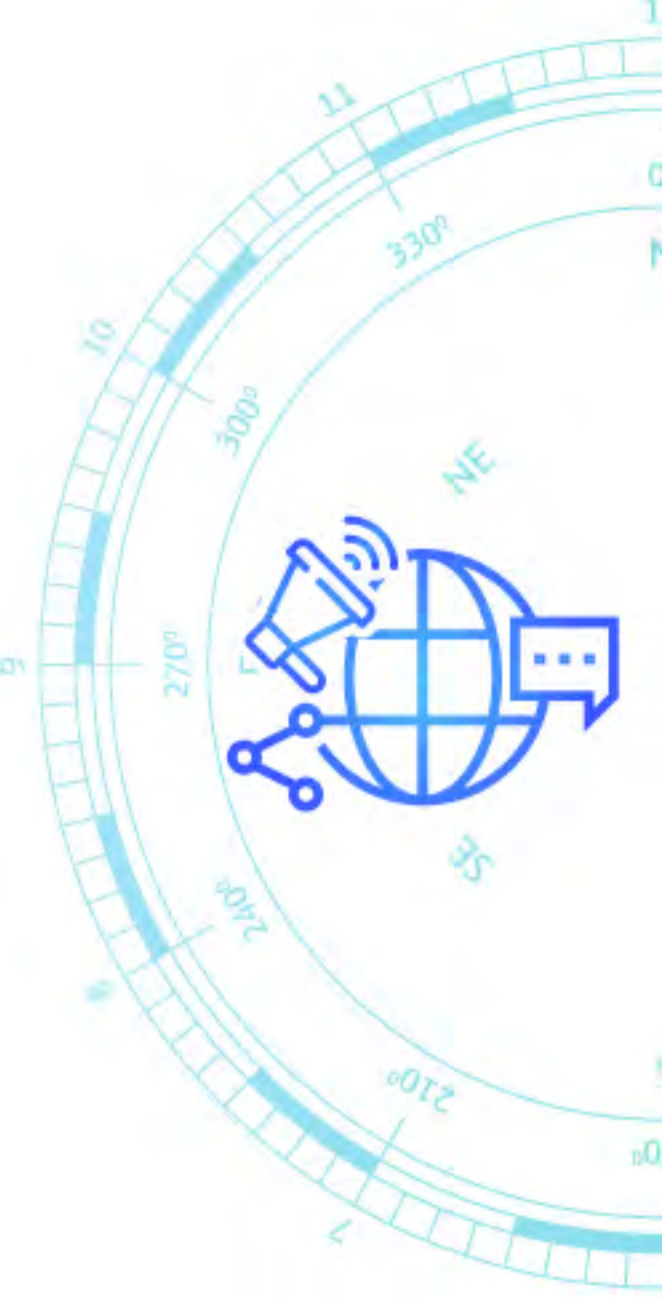

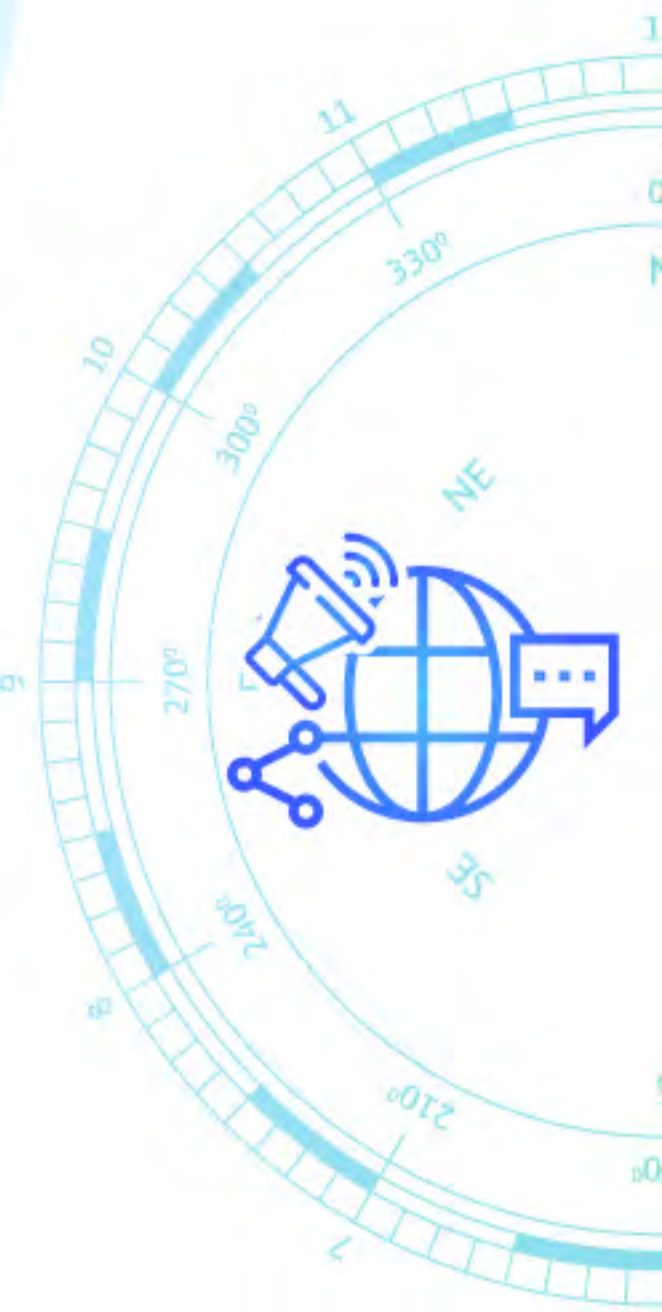

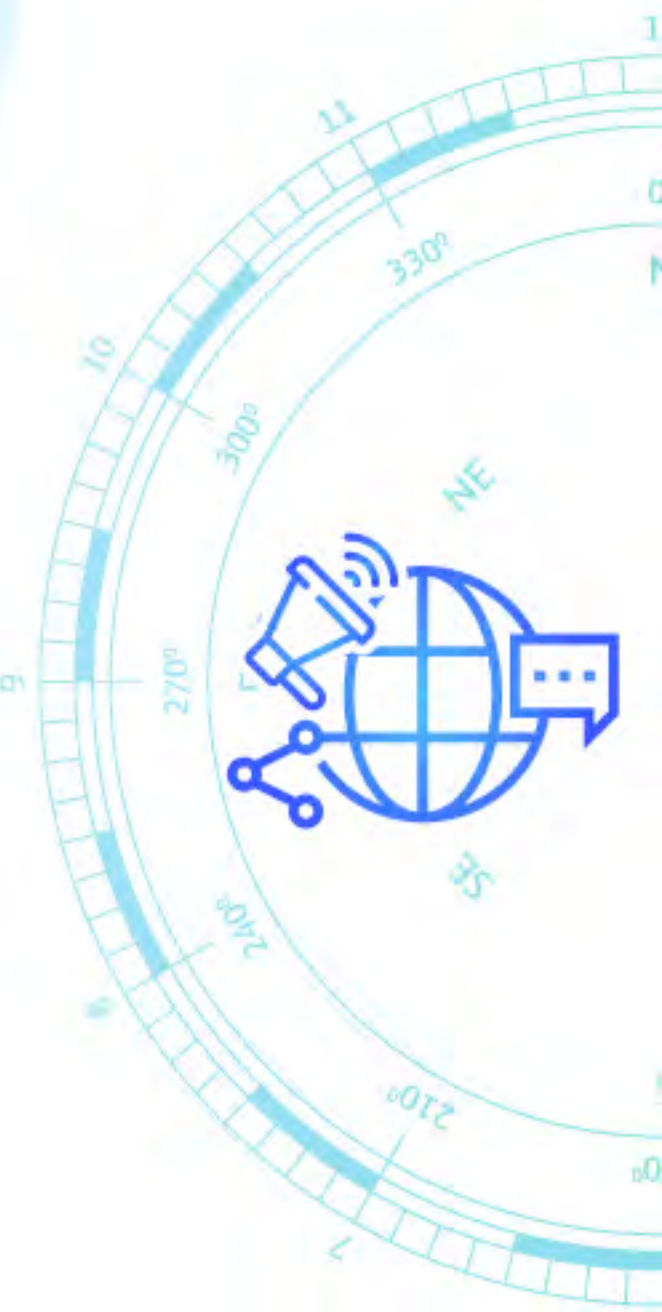
OVERSEAS MARKET DEVELOPMENT LONDON, UNITED KINGDOM

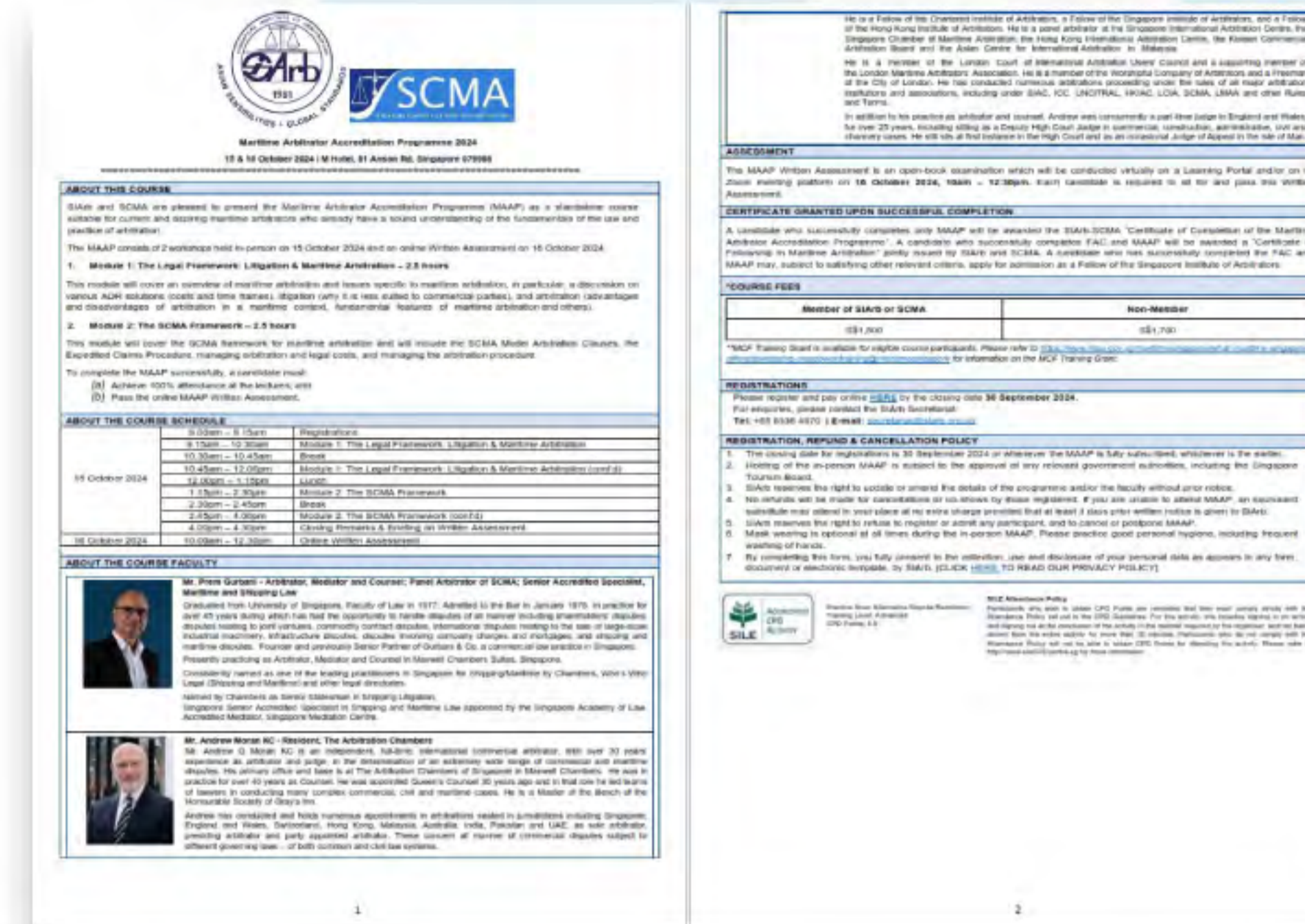
4TH MARITIME ARBITRATORS' ACCREDITATION PROGRAMME (MAAP)

This year, we welcomed 14 participants from Australia, Bangladesh, China, Indonesia and Singapore.



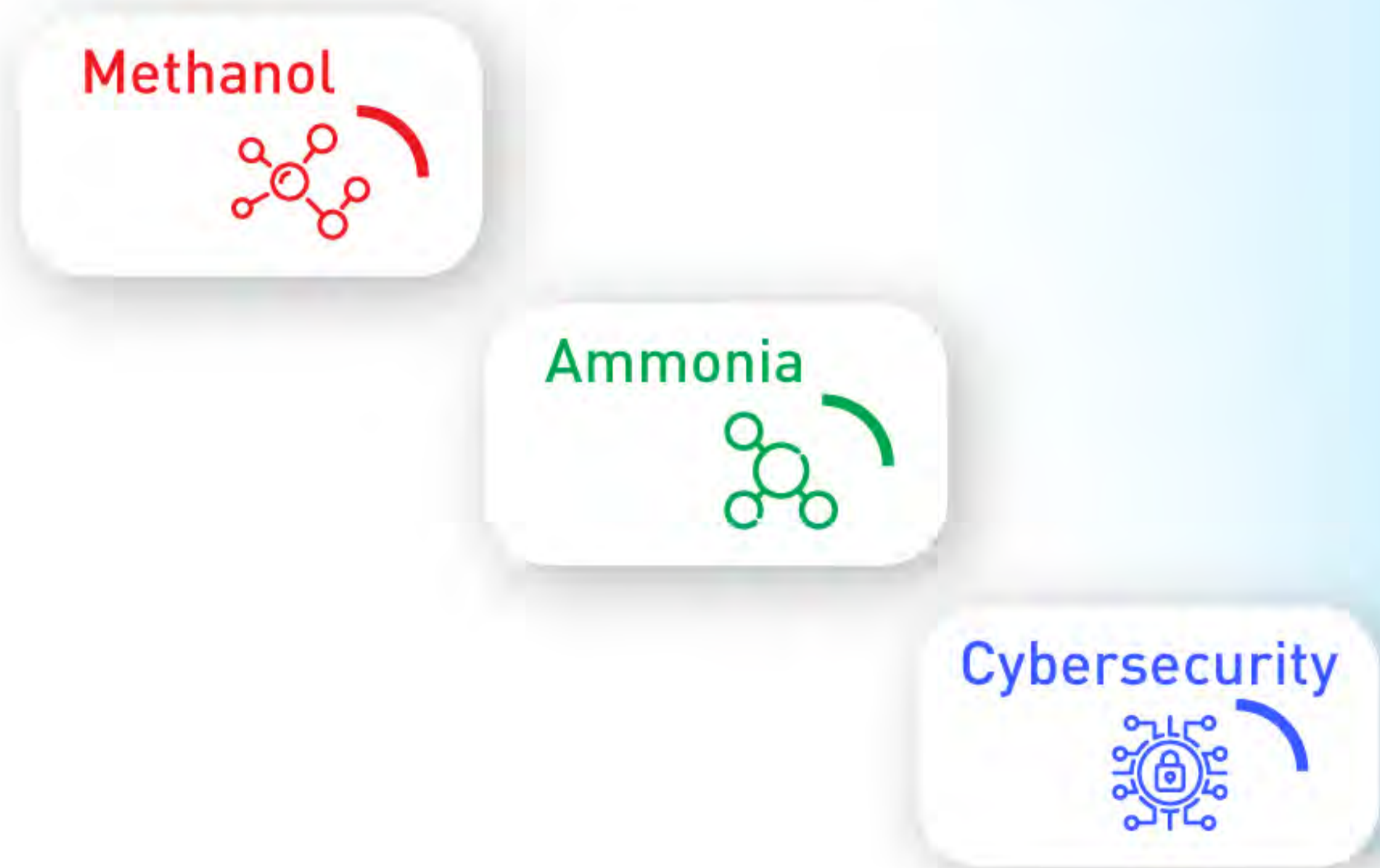
WORKING GROUPS

The workgroups for methanol and ammonia are currently reviewing and evaluating the respective value chains to identify relevant gaps and opportunities for the creation of new standard form contracts or clauses. Where appropriate, they will also make representations to the relevant international bodies and position Singapore at the forefront of industry, environmental, and legal innovation in the maritime sector.

The workgroup for cybersecurity will propose a methodology to measure the economic losses arising from cyber incidents in the maritime sector.



Methanol Working Group

- Reviewing and evaluating methanol value chains

The Work Group met twice in 2024. Last August, SCMA served as a Sounding Board for BIMCO's Methanol Annex, which aims to supplement the BIMCO Bunker Terms 2018.

On 29 November 2024, this Work Group set a key objective to create a set of contract clauses and terms for ammonia bunkering that are commercially executable.

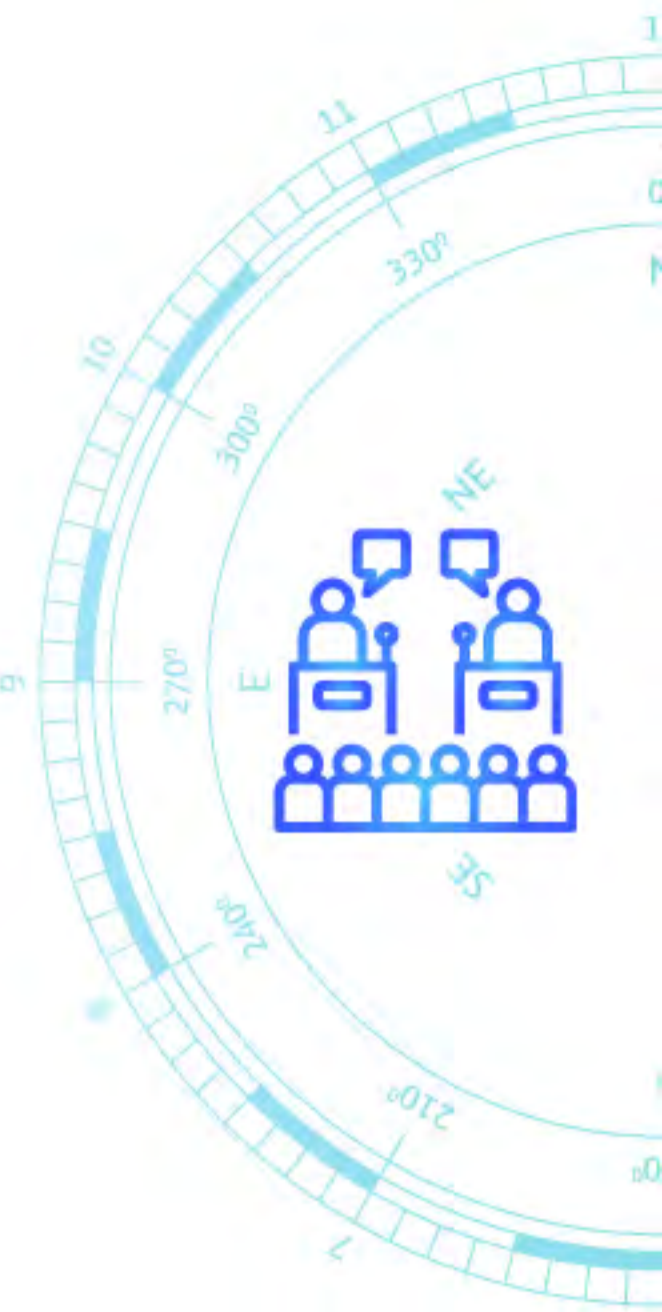
SCMA INTERNATIONAL MARITIME LAW ARBITRATION MOOT (IMLAM)

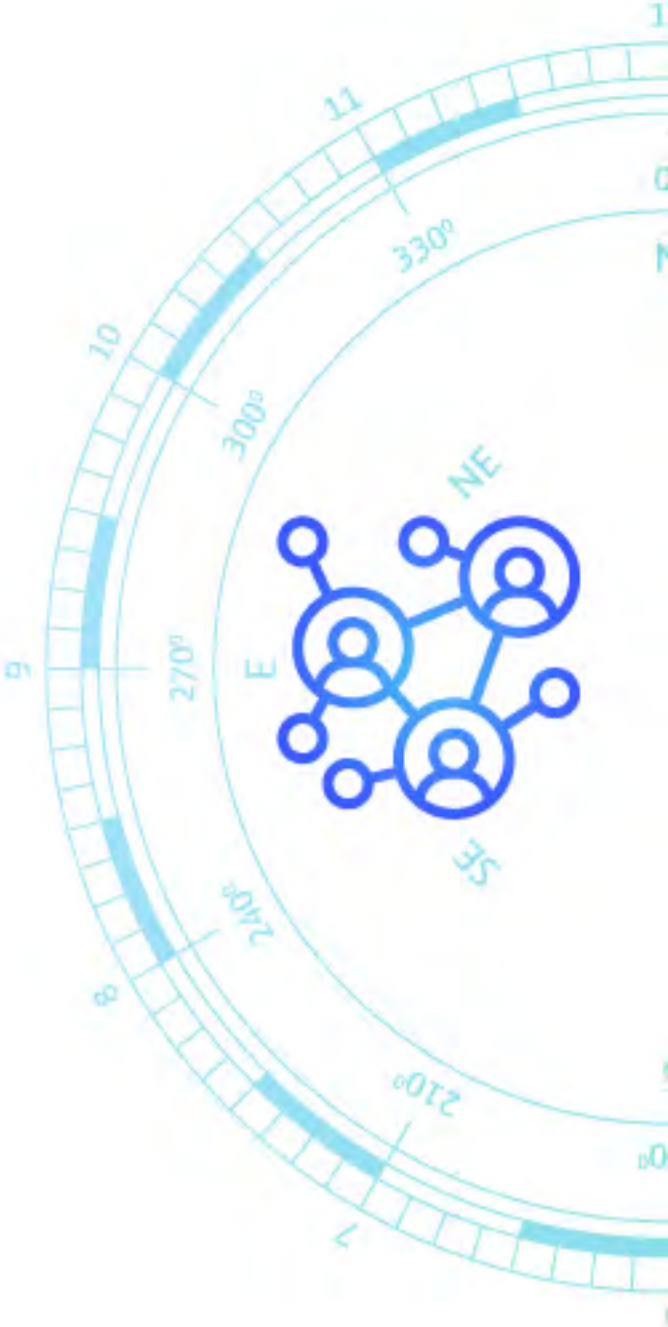
